- Payment - The funeral account for all services is due for payment two full working days prior to the date of the funeral service, unless otherwise agreed by us in advance in writing.
- Payment Types - BACS Direct Bank Transfer / Credit or Debit Card / Cheque / Cash
- Non Payment - If you fail to pay us in full on the due date, we may charge you interest at a rate of 4% above our bank's base rate; calculated (on a daily basis) from the date of our account until payment; compounded on the first day of each month; and before and after any judgement (unless a Court Order states otherwise).
